VI. ACTION ITEMS:

A. Fiscal Year 2022 Write-Offs for FYE June 2021:

At the end of each year, LL&P writes off the balances from accounts that have been closed, collections attempted, and/or liened, and that have had no activity since June of the previous year.

The current write-off amount for 2022 is \$440.44, which is 0.00511% of FY 2021's total electric sales and late fees. Compared to last year, this write-off amount decreased \$259.51, a 37% improvement.

The board praised the customer service department for such a small amount! Over the past eight years, the write off amount has steadily decreased and we hope to continue the trend.

It was MOVED BY FONGER, SUPPORTED BY CRAWFORD, to approve the Fiscal Year 2022 Write-offs for FYE June 2021.

Though the choice of which proposal will be accepted is solely the City Council's decision, the LL&P board provided commentary and guidance to City Council Liaison Salzwedel to take to City Council. The board commented that five of the six proposals met the requirements of the RFP and should be considered. No formal action was taken.
