# 2023 Energy Smart Residential Program Equipment Specification & Document Requirements

## Equipment Specifications & Documentation Requirements

### GENERAL PROGRAM RULES

This offer is valid only for Lowell Light & Power residential electric customers for a limited time. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2023, and **application must be received on or before December 31, 2023**. Lowell Light & Power reserves the right to withdraw or change this offer without notice. **Rebates may not exceed purchase price**. Ineligible rebate requests are subject to denial or repayment to program. Call **(616) 421-2514** for more information.

### EQUIPMENT SPECIFICATIONS

**Central Air Conditioning:** AHRI Certificate required to verify efficiency for SEER 15, 16, or 17.

**Mini-Split Heat Pump:** AHRI Certificate required to verify efficiency. Make and model numbers for indoor and outdoor units required. SEER 18+.

**ENERGY STAR® Products:** To verify purchase, please send in a copy of the receipt with the product model numbers on it. Additionally, provide proof of ENERGY STAR® certification. Limit of 25 LED bulb rebates per customer per year. Refrigerator must be 10 cubic ft. or larger.

**ENERGY STAR® Heat Pump Water Heater and ENERGY STAR Pool Pump:** To verify purchase, please send in a copy of the invoice with the installation date, receipt with the indoor and outdoor product model numbers on it, and technical specification sheets.



**ENERGY STAR® Electric Clothes Dryer:** Must replace a standard efficiency electric clothes dryer. New unit must be ENERGY STAR® certified.

**Advanced Power Strip Surge Protector:** Does not require ENERGY STAR qualification. The advanced power strip surge protector must be new and have one or more outlets that have integrated automatic (controlled) shut-off when connected equipment is not being used. A copy of the receipt from the store where the Advanced Power Strip was purchased is required. Limit 4 rebates per customer per year.

**Programmable Thermostat:** Must be installed in a home with central air conditioning.
