If no option is checked, rebate will be posted as credit to the account holder.

Rebates will not be reissued if account holder or contractor preference changes after rebate is processed.

Residential Energy Smart Rebate Application Equipment Specifications & Documentation Requirements

GENERAL PROGRAM RULES

This offer is valid only for Lowell Light & Power residential electric customers for a limited time. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2024. Your completed application and required documents must be received by December 31, 2024, or within 90 days, whichever is later. Lowell Light & Power reserves the right to withdraw or change this offer without notice. Rebates may not exceed purchase price. Ineligible rebate requests are subject to denial or repayment to program. All equipment must be new and installed in a residential dwelling where electric service is provided by Lowell Light & Power. Call **(616) 421-2514** for more information.

To verify purchase, all applications must include a copy of the invoice/receipt indicating the make, model, payment in full, and date of purchase. See below for specific requirements and/or documents that need to be included with this application based on equipment.

EQUIPMENT SPECIFICATIONS

Central Air Conditioning: Include the AHRI Certificate to verify efficiency for SEER2 14.3, 15, or 16. The indoor coil and outdoor condenser must be a matched set and installed on the same date to be eligible.

Heat Pumps: Heat pumps must be the primary method of heating and cooling the space. Include the AHRI Certificate to verify efficiency for SEER2 and HSPF2. If applying for a cold climate heat pump rebate, include the performance specs showing the COP at 5°F. Rebates cannot exceed \$2000 for cold climate heat pumps or \$1000 for all other non-cold climate heat pumps. Customers purchasing a new furnace or other home heating system in addition to the heat pump are ineligible for the cold climate rebate.

Efficiency requirements for heat pump rebates:

Heat pumps not rated cold climate: HSPF2 \geq 7.5 and SEER2 \geq 13.4.

Cold climate heat pumps for non-ducted systems: HSPF2 \geq 8.4, SEER2 \geq 14.3, and COP \geq 1.75 at 5°F.

Cold climate heat pumps for ducted systems: HSPF2 \geq 7.7, SEER2 \geq 14.3, and COP \geq 1.75 at 5°F.

ENERGY STAR® Refrigerator, Freezer, Dishwasher, Clothes Washer, Electric Clothes Dryer, Heat Pump Clothes Dryer, Room AC, Air Purifier, Dehumidifier, PC, TV, and LED Light Bulbs: Provide proof of ENERGY STAR certification with this application. Refrigerator must be 10 cubic ft. or larger. Limit of 25 LED bulb rebates per customer per year.

ENERGY STAR® Heat Pump Water Heater and Pool/Spa Pump: Provide proof of ENERGY STAR certification with this application. Include technical specification sheets.



Advanced/Smart Power Strip: Does not require ENERGY STAR qualification. The advanced power strip must be new and have one or more outlets that have integrated automatic (controlled) shut-off when connected equipment is not being used. Limit 4 rebates per customer per year.

Programmable Thermostat: Must be installed in a home with central air conditioning.
